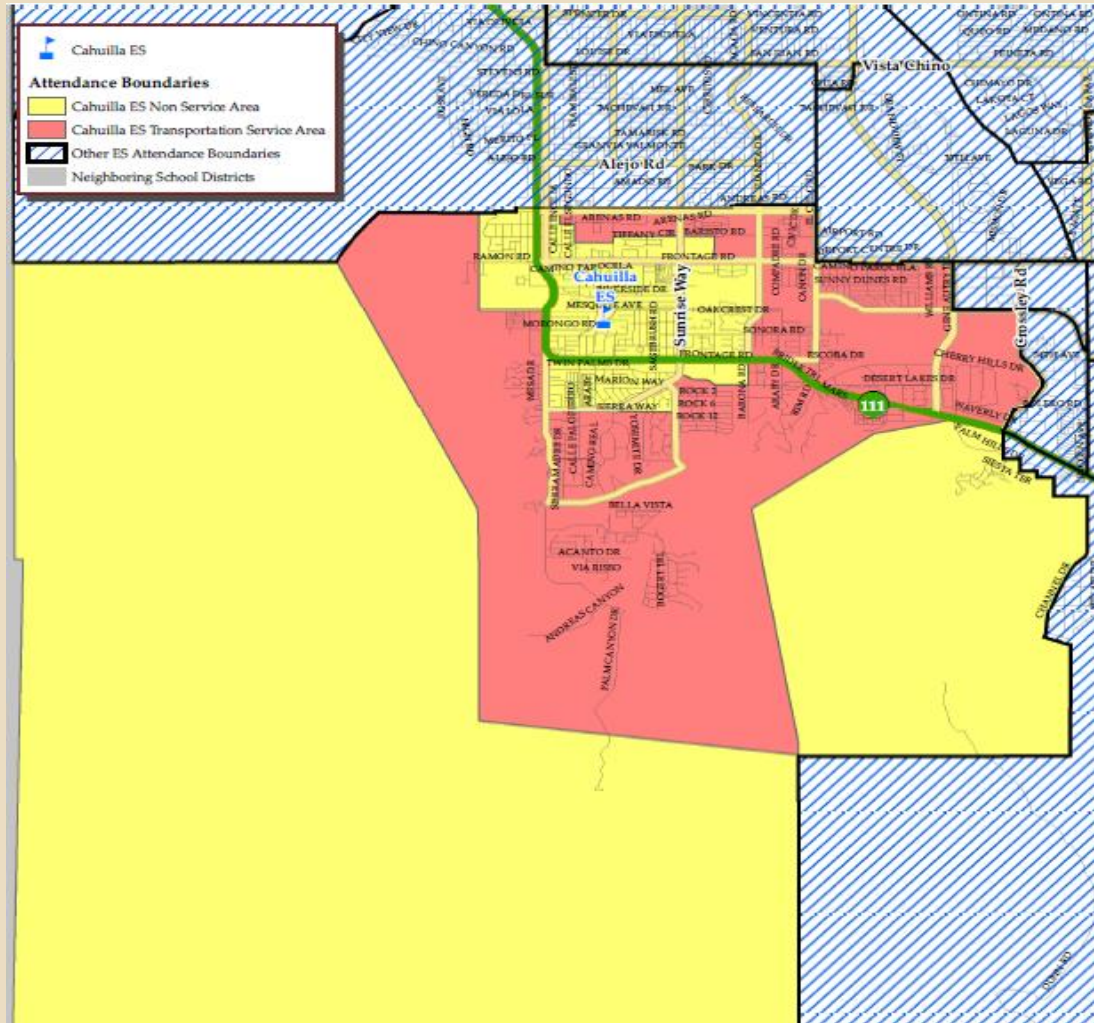
Cabot Yerxa ES Map

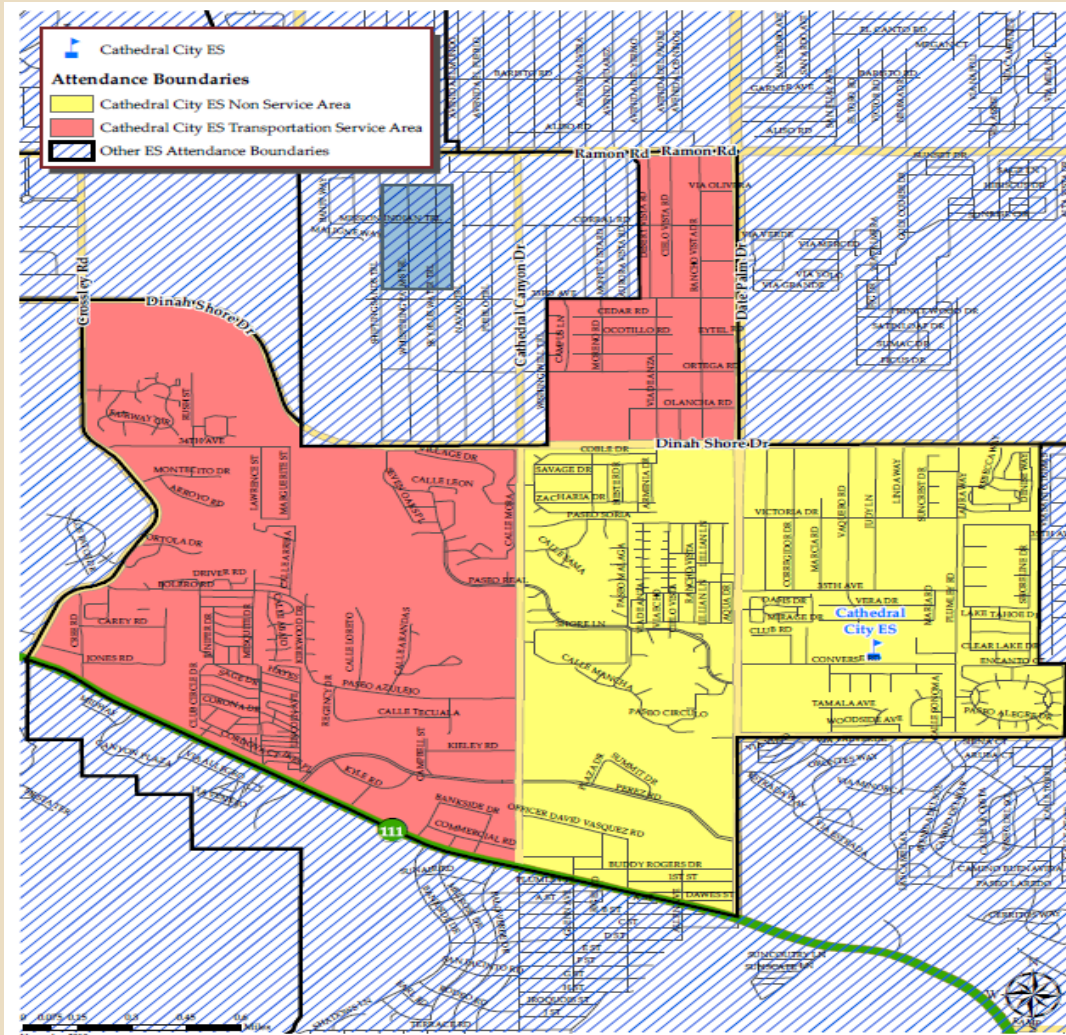


Cahuilla ES Map

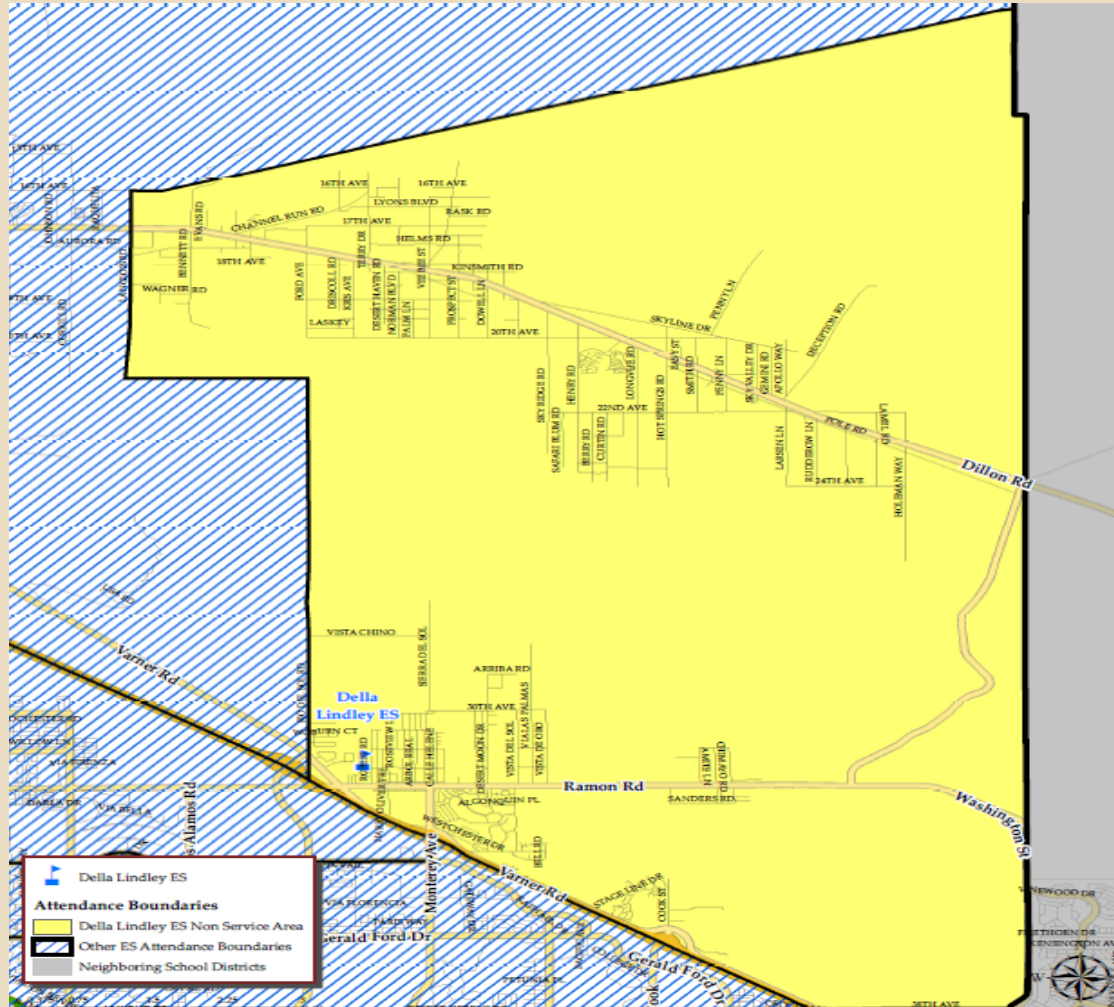

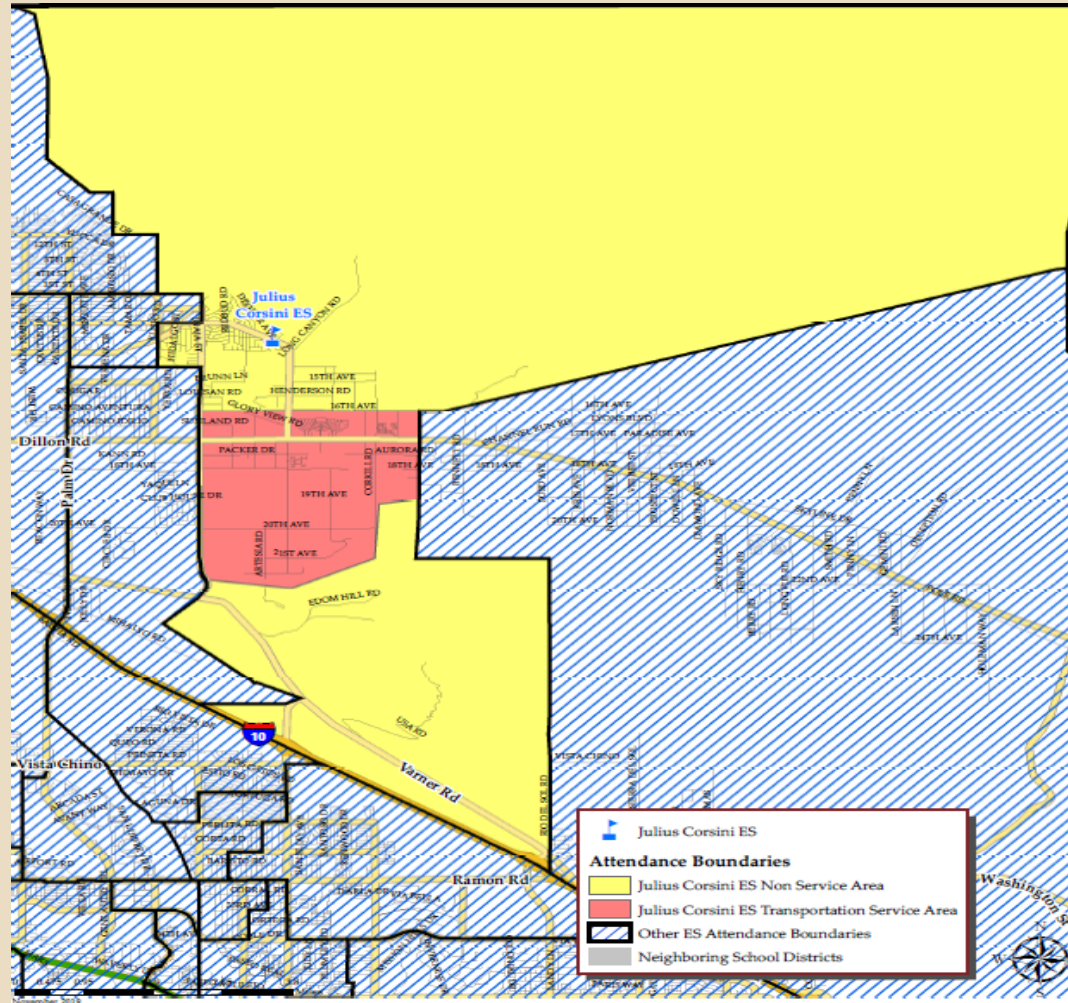
Della S. Lindley ES Map

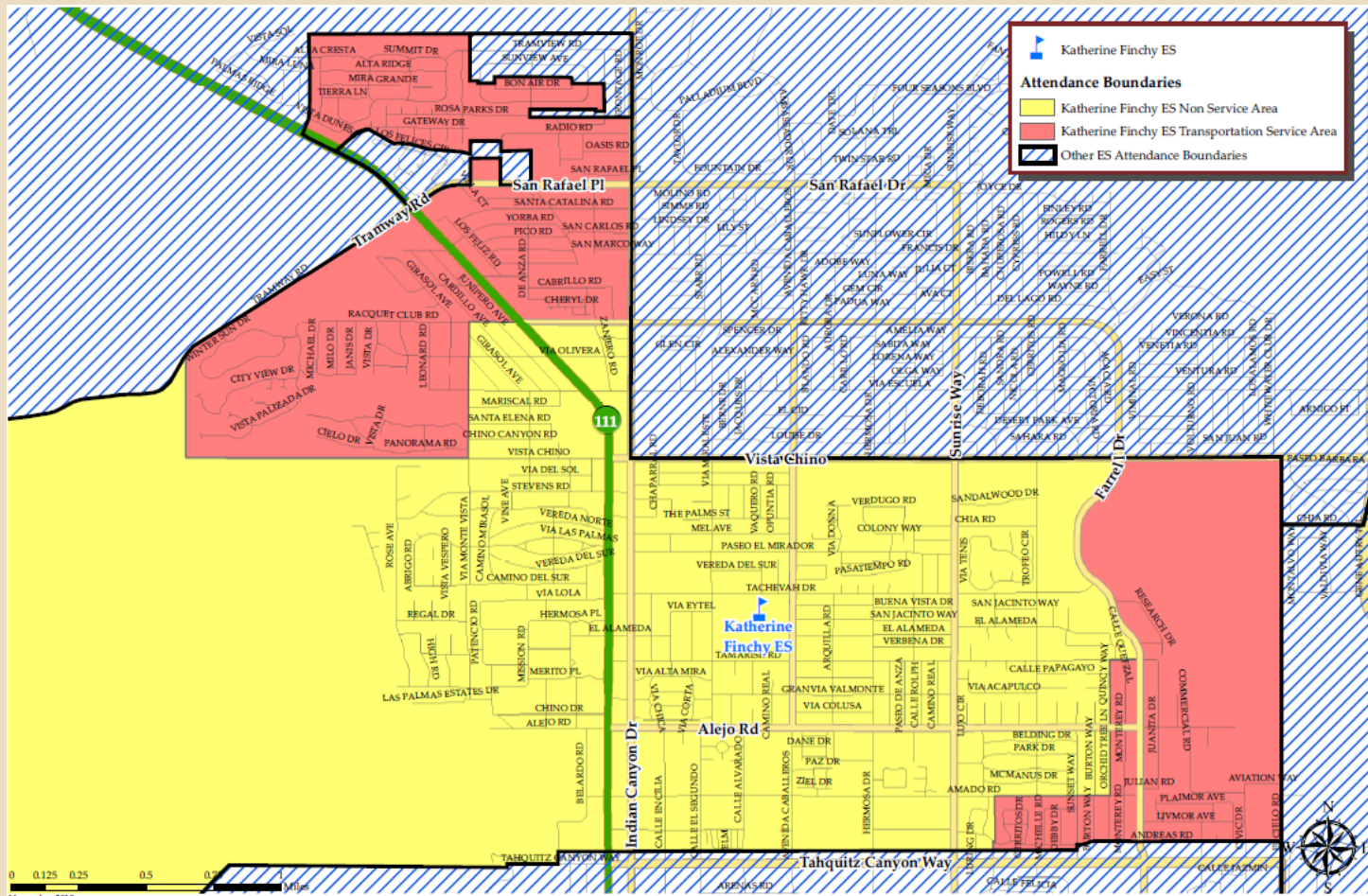
Julius Corsini ES Map

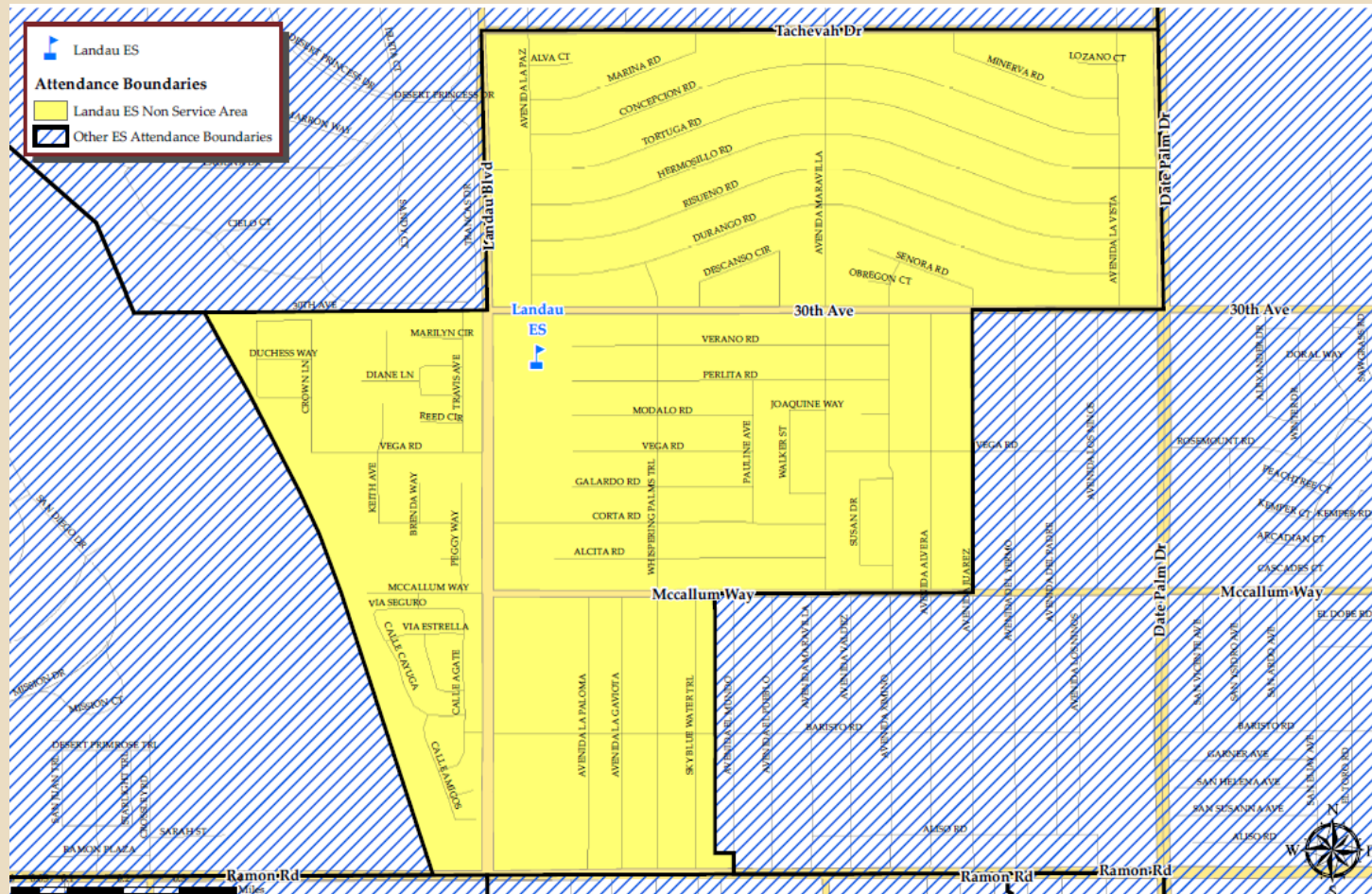


Katherine Finchy ES Map

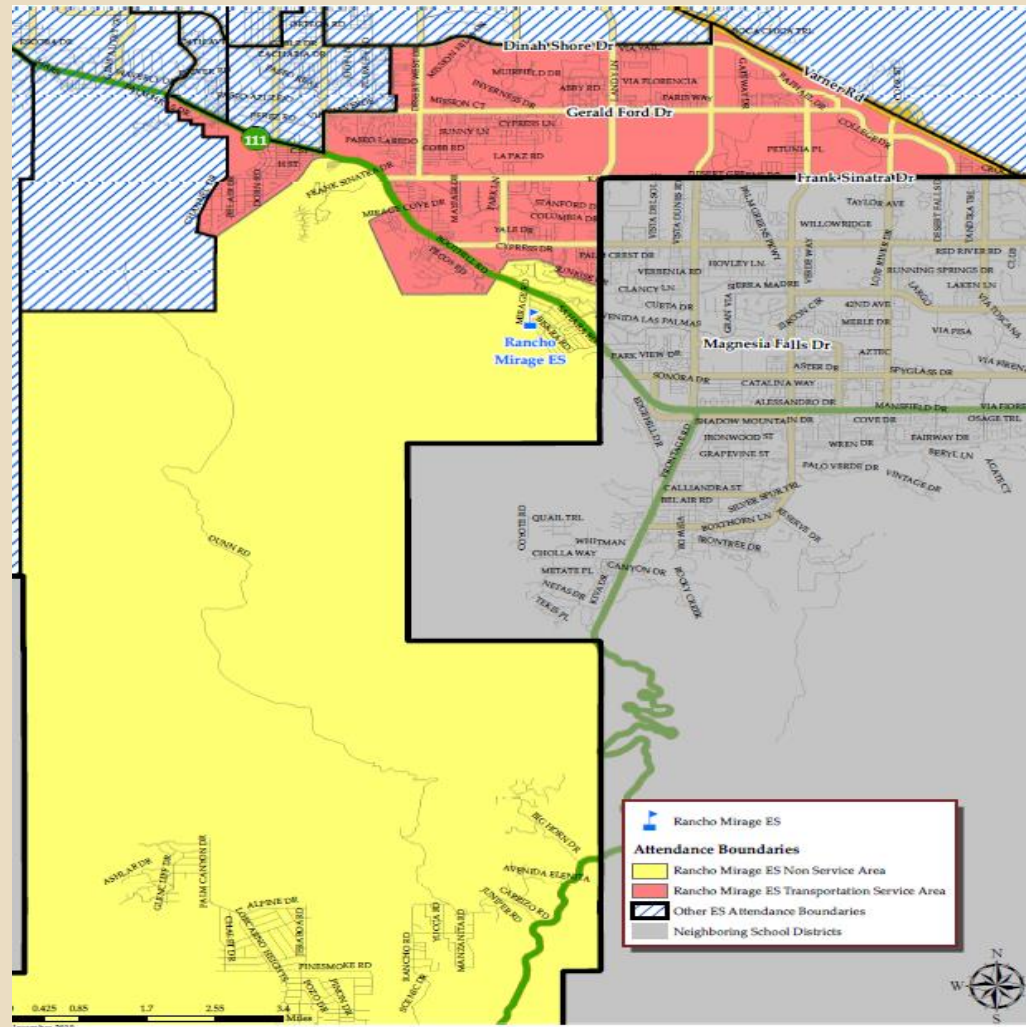

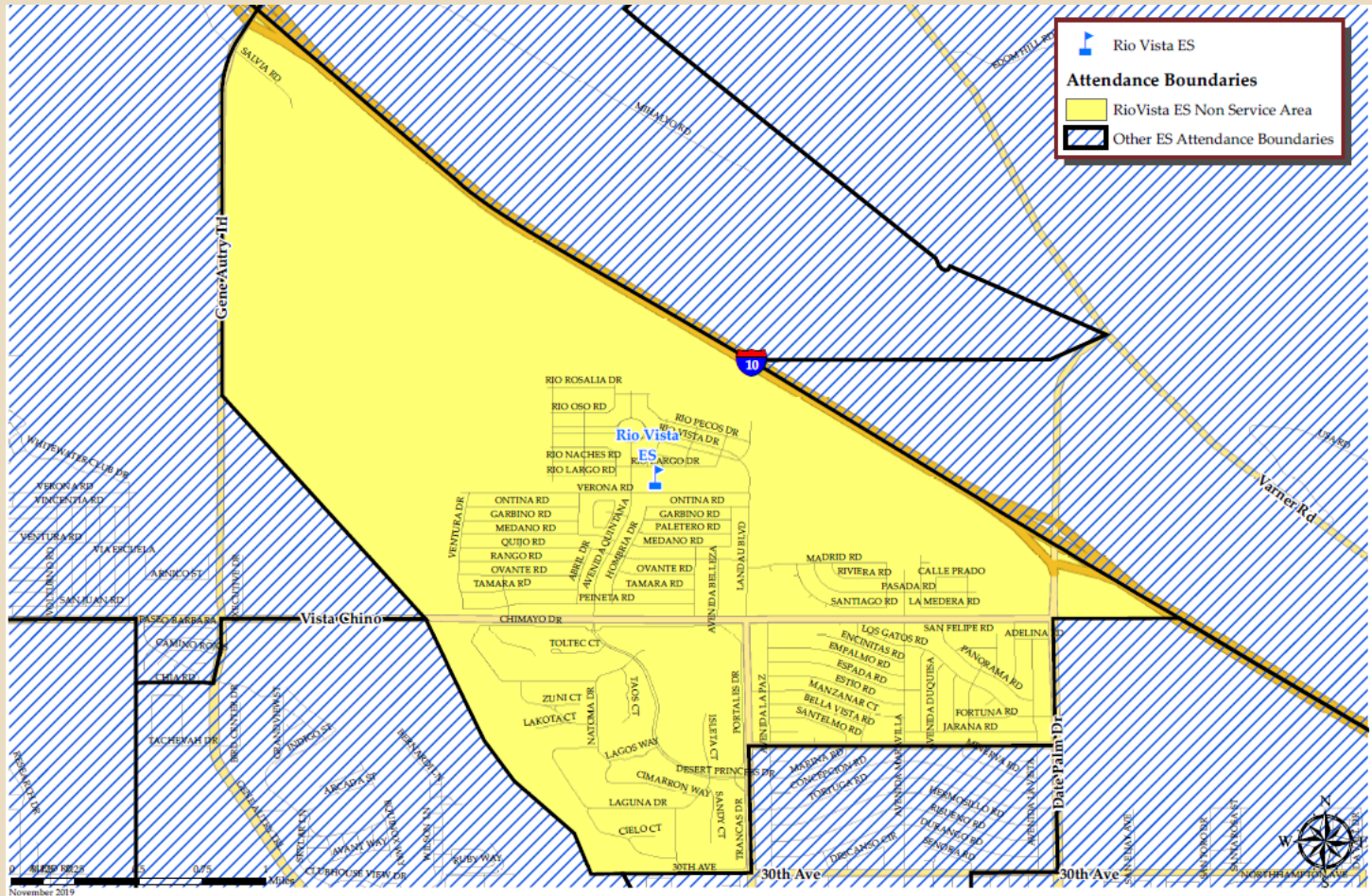
Rancho Mirage ES Map

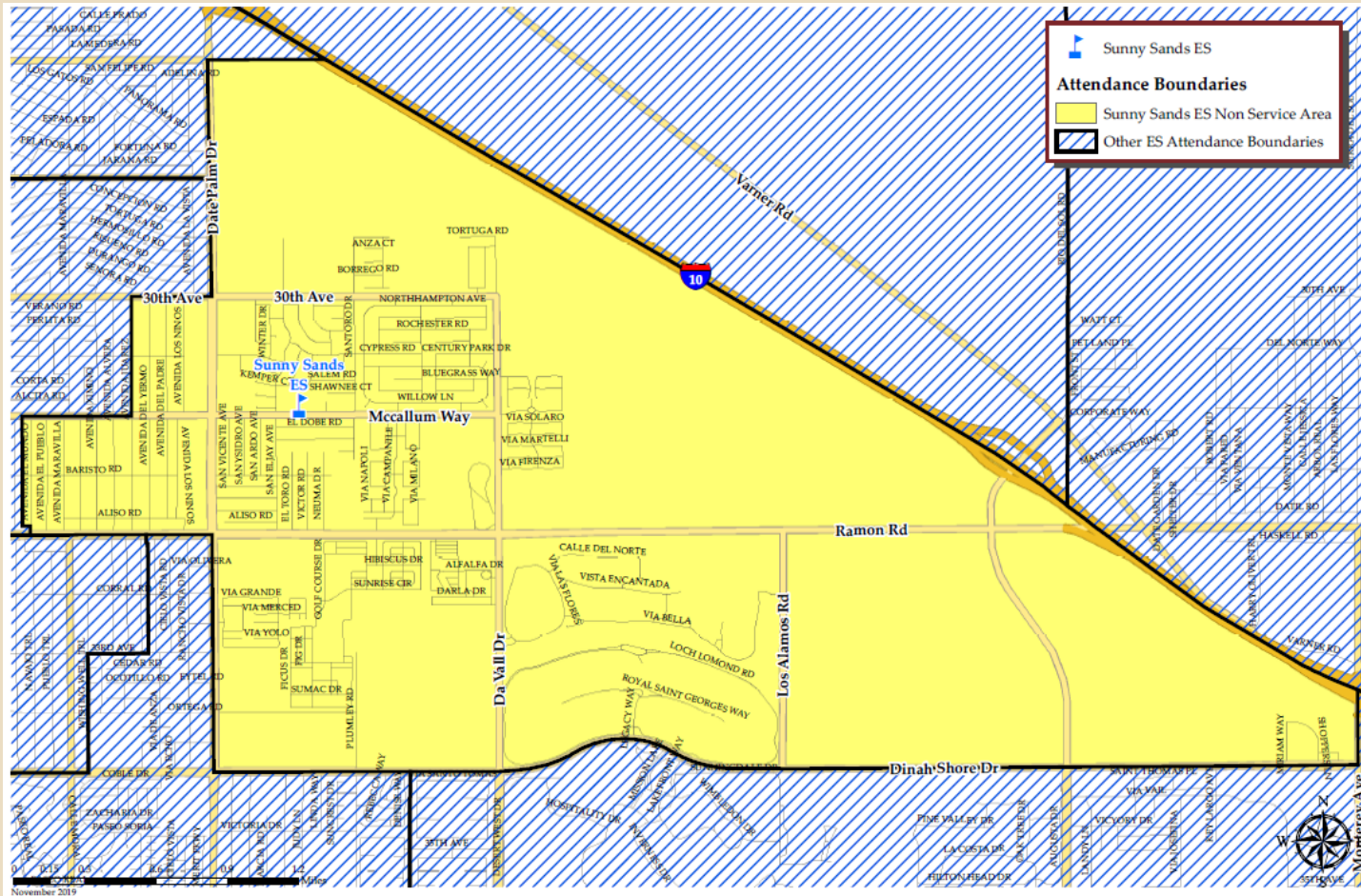


Rio Vista ES Map

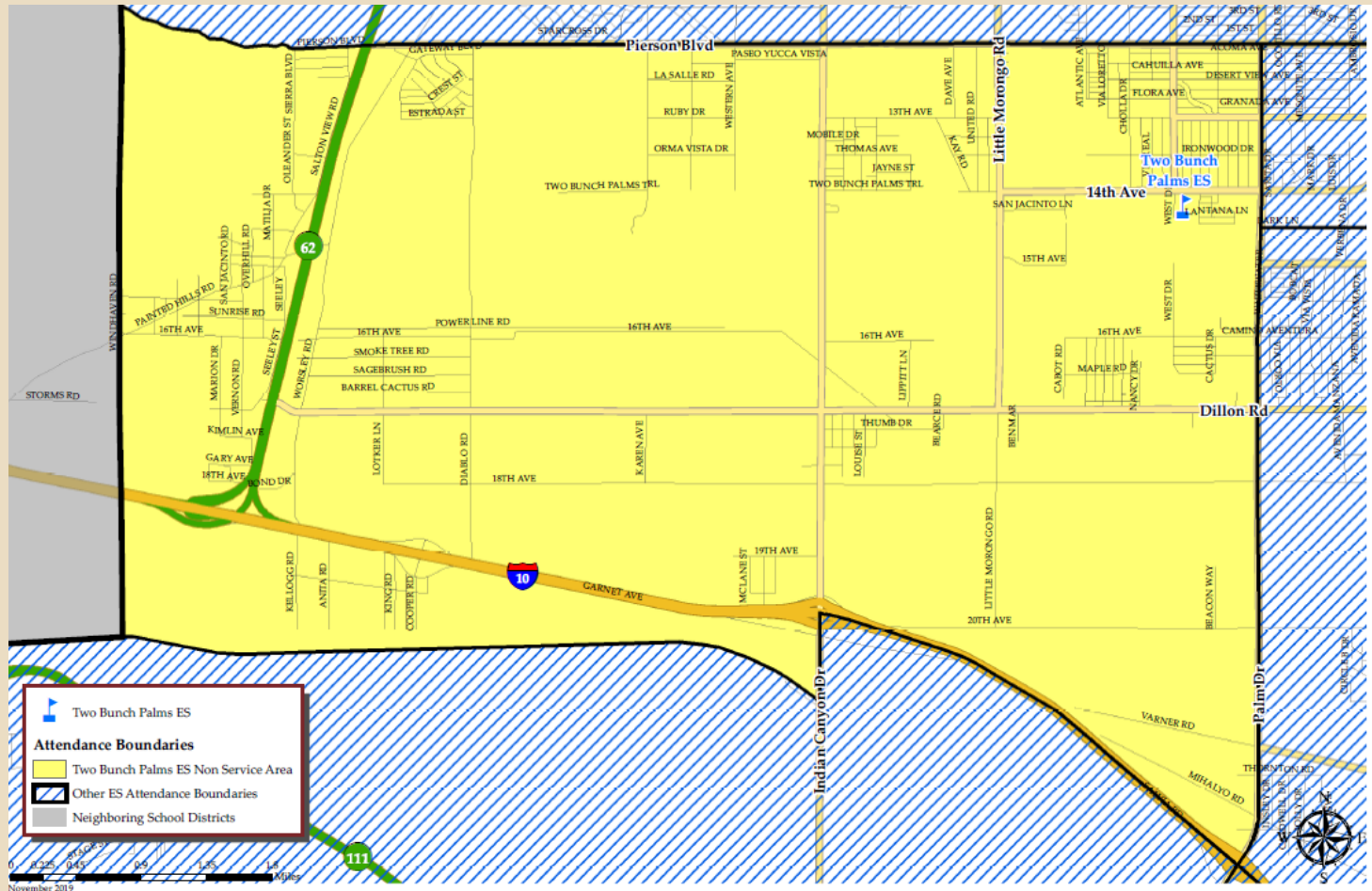

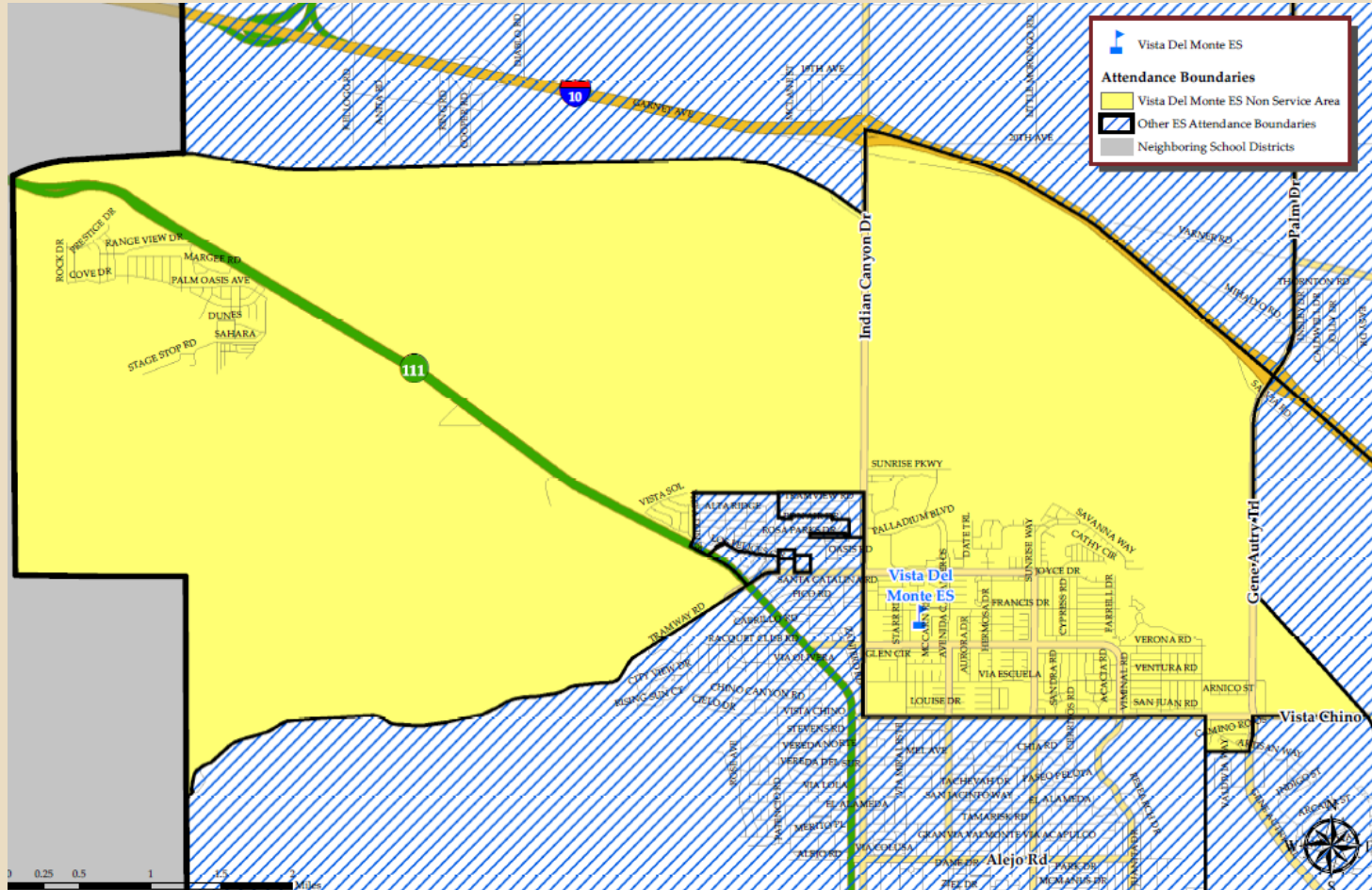
Two Bunch Palms ES Map

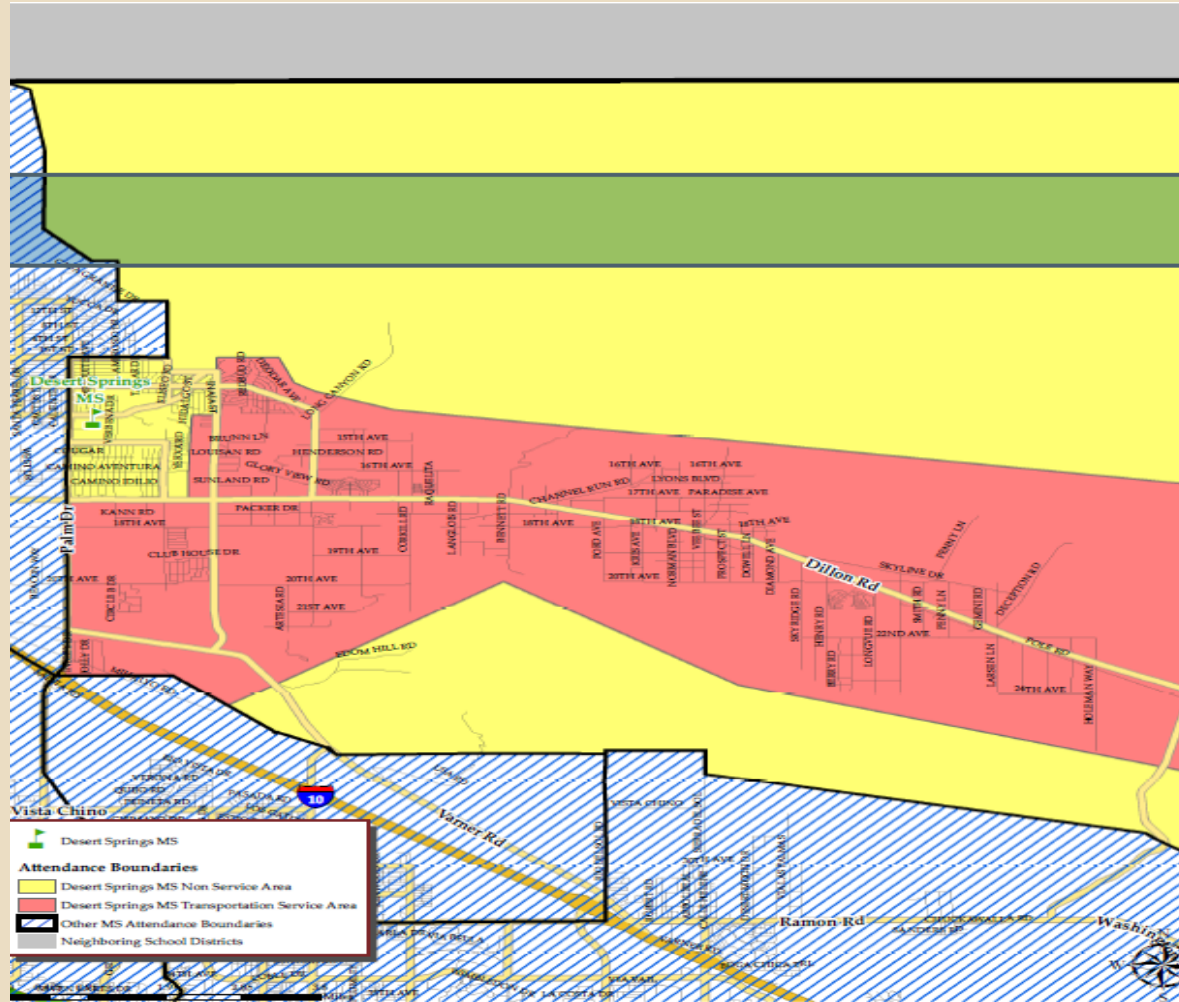
Vista del Monte ES Map

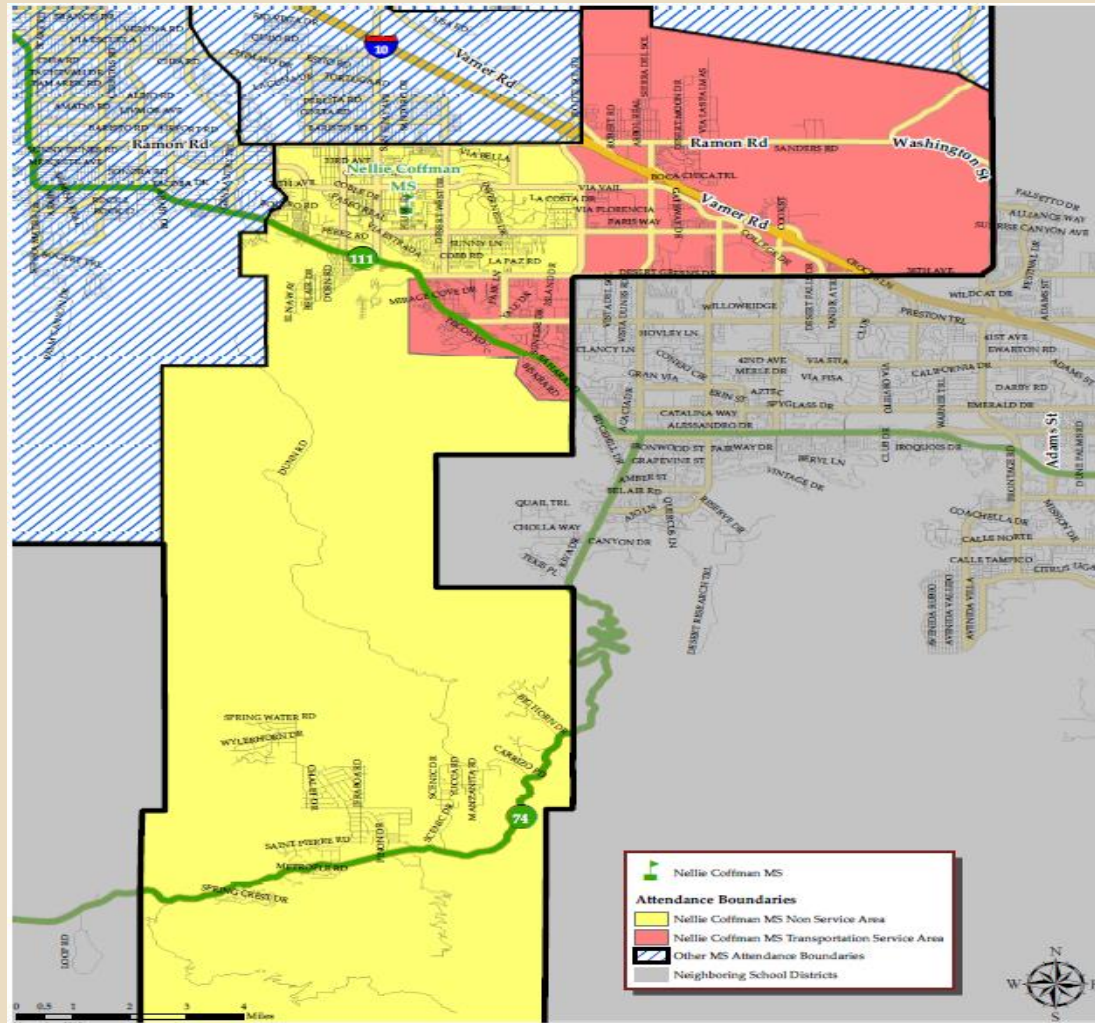
Desert Springs MS Map

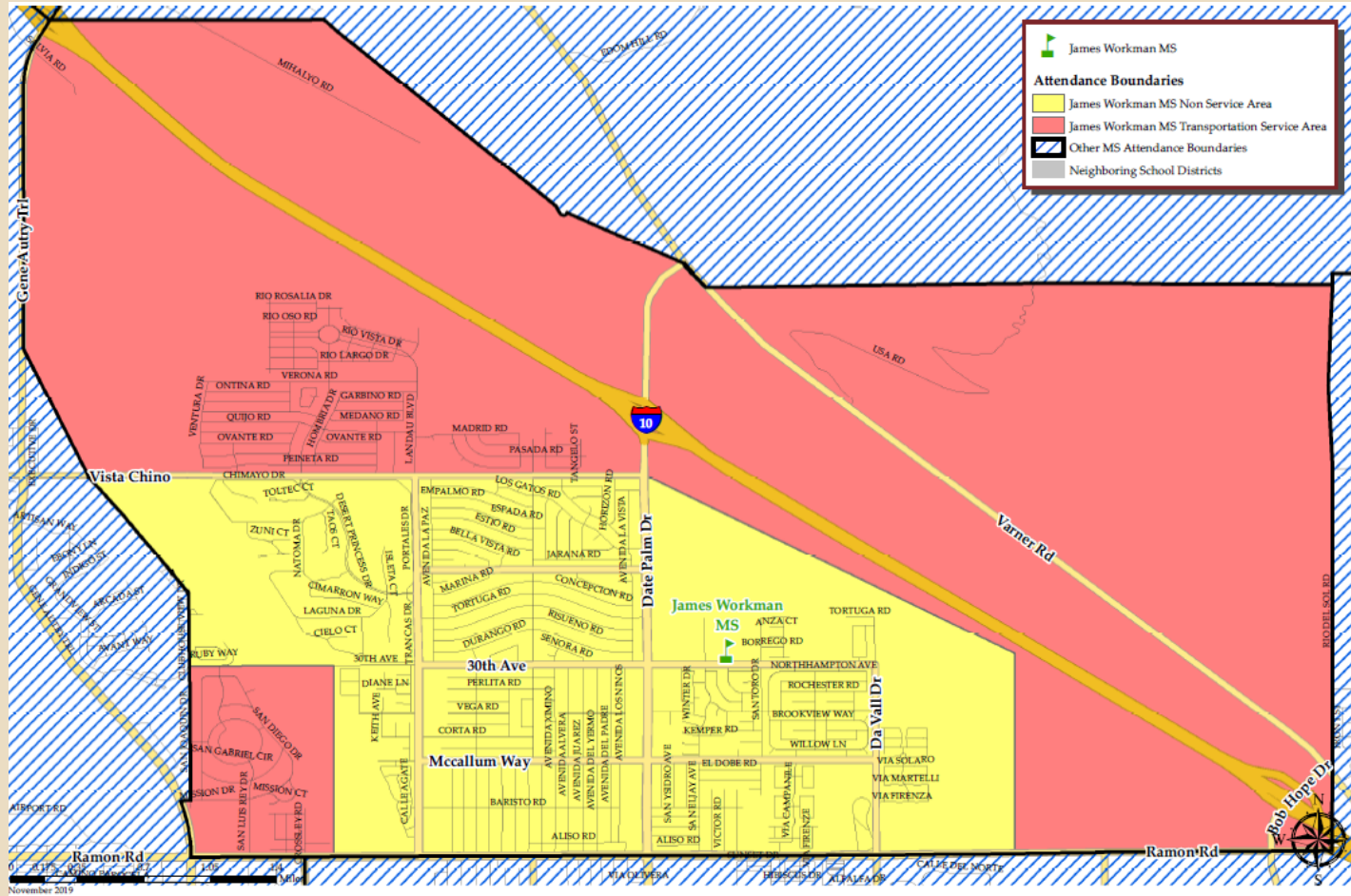
Nellie Coffman MS Map

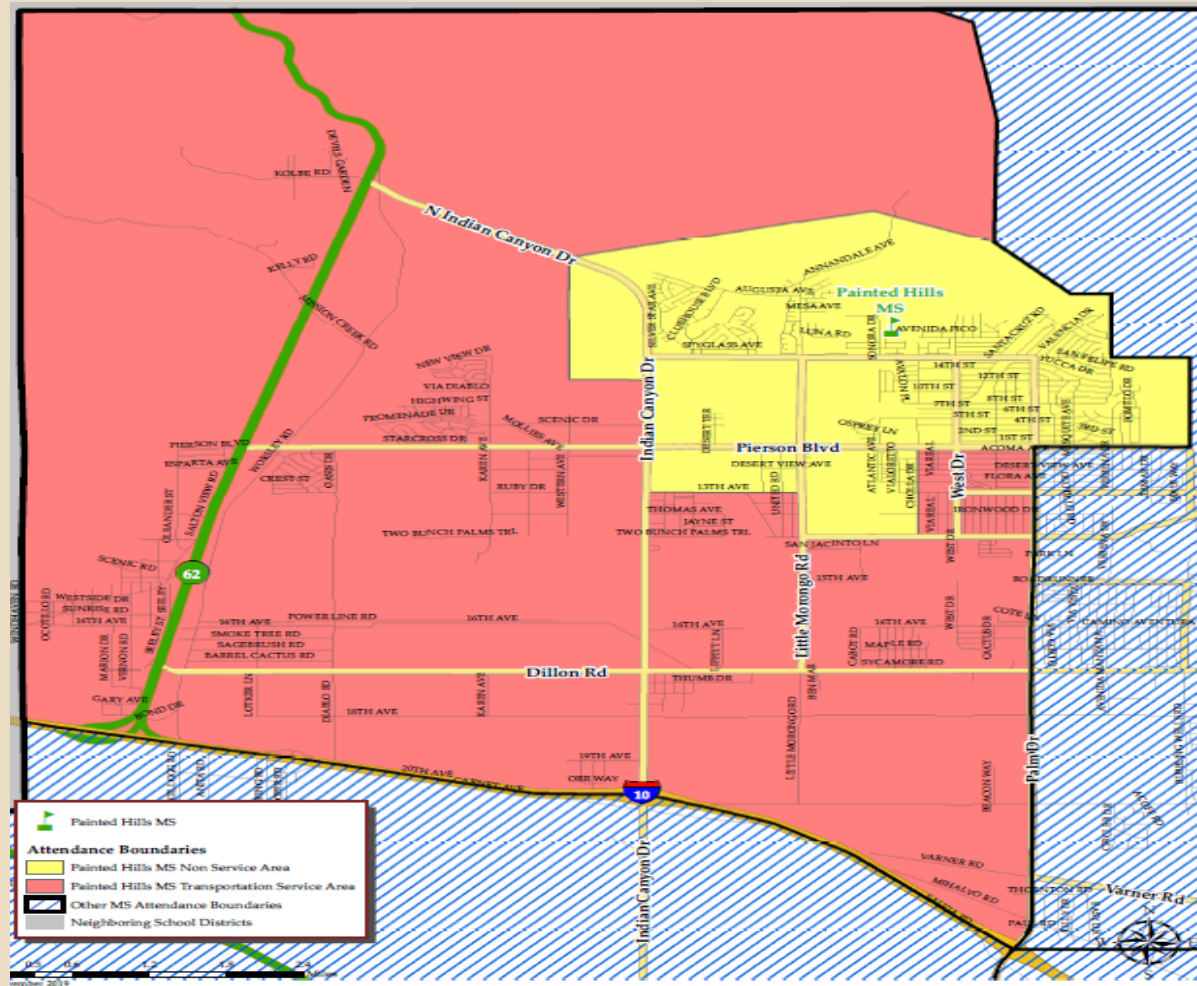

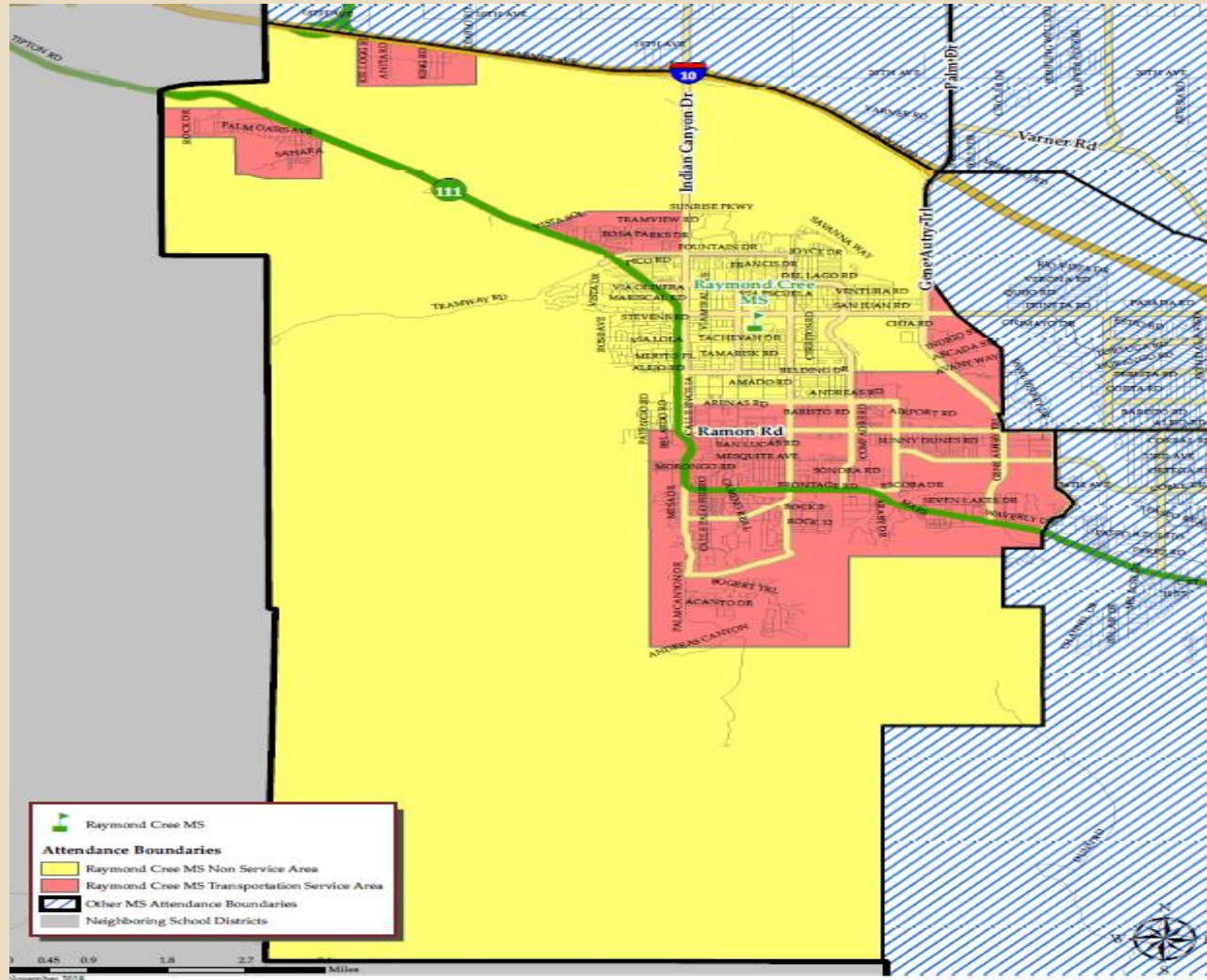
Painted Hills MS Map

- Type 1 Transit: holds 78 or more Gen. Ed. Students
- Type 1 Conventional Wheelchair Bus: holds 30-40 students depending on configuration
- Type 2 Ambulatory Bus: holds 20 or more students
- White Fleet Van: holds 4-6 students for Gen. Ed./SPED

- CHP written and drive test every 5 years
- D.O.T. physical / DMV Class B Commercial License / CDE issued School Bus Certificate
- DOJ, FBI fingerprints & First Student company background clearance

Bus Driver Training (Cont.)

- Minimum 20 hours of classroom training (CA STATE)
- Minimum 20 hours of behind the wheel training (CA STATE)
- Continuous annual training

Bus Driver Monitoring & Evaluation

36

- Positive check-in daily before keys are issued
- All drivers enrolled in the DMV pull notices to monitor changes in driving record
- Driver maintenance online software to monitor compliance
- Provide 10 hours of In-Service training annually
- Evaluate performance through a ride along with location safety manager or certified trainer

California Highway Patrol Requirements

37

- ❑ Inspections of the child restraint system
- ❑ Inspection includes *Child Checkmate* system
- ❑ Review bus maintenance records
- ❑ Audit driver's time and trip logs
- ❑ Review driver's credentials and background
- ❑ Inspect twice per year

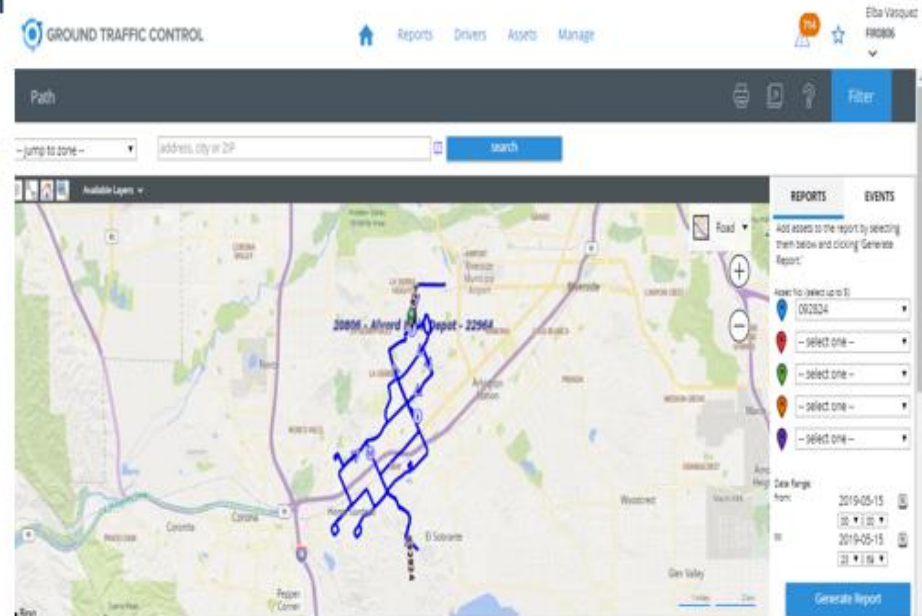
- ❑ Bus safety pre-trip inspections
- ❑ Vehicle diagnostics
- ❑ Miles traveled / fuel used / MPG
- ❑ Route replay monitor stop times and efficiency of route
- ❑ On time performance tracker
- ❑ School arrival / monitor on-time

Automated Bus & Student Checks through Zonar Systems (Cont.)

GPS is used to track efficiency of route by

- integrate technology systems and platforms for more efficient planning and management
- higher quality communication
- greater operational transparency
- capture near real-time
- transmission of vehicle subsystem data
- driver performance data



Bus Facts

41

- 153,000 miles each month and 1,000,000 combined miles for home to school and activity trips annually
- Child *Check Mate* security system on all buses as required by California State Law as of November 2018
- GPS Monitoring on all vehicles
- An average of 2,400 students transported to and from school daily
- 3 video cameras on all large buses and 2 video cameras on smaller buses and 1 camera on the white fleet vans capturing activity of drivers and students

Bus Facts (Cont.)

42

- ❑ 22 propane operated buses
- ❑ 27 natural gas operated buses
- ❑ 35 gasoline operated buses
- ❑ 3 gasoline operated white fleet vans (6 passenger)
- ❑ 8 buses 2009, all others 2016 and newer
- ❑ All buses/vans air conditioned
- ❑ 26 general education & 54 special education buses
- ❑ 3 white fleet vans (2-6 passenger/1-4 passenger)
