11. **PUBLIC COMMENTS:**

Clerk Gerrell stated that three written comments were received and sent to the Board of Education prior to the meeting:

Arielle Haze Mayer, Math Teacher – Hello Board Members, Thank you for all you have done for us this school year. We appreciate the ViewSonic touchscreens very much. Unfortunately, next school year, in a class full of 40 freshman math students, they will not be able to see the screen. I would like to request funds for DHSHS to mount these ViewSonics with the same mounting Agua Caliente Elementary has them mounted (slide down to write and slide up to see.) Right now, they take up valuable floor space, block counters and cabinets, and most unfortunately, they can't be seen from the back of the room.

They could be very useful but may be pushed aside or put into storage until we can find a way to mount them, so they are visible to all students, and won't block valuable cabinets and counter space. Thank you in advance, for your consideration.

Nayeli Figueroa – My name is Nayeli Figueroa. I am writing today to ask the board to not approve this draft of the LCAP as it is still allocating \$400,000 dollars of money intended for "actions and services ... principally directed towards meeting the PSUSD goals for its high needs students of low income students, English Learners, and foster youth." To institutions that continue to perpetuate the detriment of people in these exact communities.

Although I believe the data collected to be skewed due to insufficient sample size and Inaccessibility to the online survey for the folks this money affects the most, the student and parent data discrepancies should indicate the disconnection between what they each perceive "safety" to be. I do not believe there has been sufficient efforts to ask students what would make them feel more safe and I can almost guarantee "another police officer at my school" will not be an answer.

CV Students First has had these conversations with students. Students themselves have expressed they need mental health resources and teachers and counselors that are not so overworked that they still have the mental capacity to care. They have expressed needs for college mentoring, scholarships, and shared feelings of discouragement by the lack of information. Let's better use this \$400,000 dollars to support our high needs students in the ways they need it the most and not on maintaining a position that is ironically depriving our students of their resources.

Faustina Sevilla, Riverside County Parent Union Ambassador – Good morning, The following is my public comment, which I would like to be read out loud at today's Board meeting: "I am writing to you as a concerned parent and although I do not reside within your district, it is my duty to advocate and to make sure that all children have their educational needs taken care of.

What you allowed to take place since pandemic began is shameful. You know very well, that you could've done more for our children. But like many other districts, you allowed the union to control what took place, thus failing our children and parents when they needed you to fight for them. There was a recent article that mentioned your plan to full-time instruction beginning in the fall. I am expecting no less from you, it is past the time that you step up and do what's right.

As board members you must take the time and also view, in detail, any curriculum that may be introduced. There are some that if approved by you, would serve no benefit to our children but would rather affect their mental well-being even more. You would also be putting those teachers that don't agree with these in a tough spot of teaching this or lose their pay. Teachers are not their students parents nor should they be put in a situation in which they are taking on that role with our children. You must stick to basics when deciding what is appropriate to teach our children. You can decide to finally listen to parents and do what's best for our children or continue to do as you please.

Regardless, I will continue to fight for school choice, not the one that currently exists but rather one in which funds will follow the child. For now, enjoy the power that you have.

- Public Health Update – Riverside County remains in the orange tier a case rates are steadily improving. We are at 1.6 cases per 100,000 and the state rate is at 2.0. 1. The minimum recommended reserve for economic uncertainties for each year identified in the budget.
2. The amount above the minimum recommended reserve, assigned and unassigned combined, for each year identified in the report.
3. A statement of reasons that substantiates the need for the amounts listed in item (ii) for each year identified in the budget.

The information required in items (i) through (iii) is included in the Statement of Assigned and Unassigned Ending Fund Balances Above the State Recommended Minimum Level.

15.c. APPROVAL OF CONSTRUCTION RIGHT OF ENTRY AGREEMENT WITH GHA COMPANIES AT THE BARISTO PROPERTY (OE-12.12)

The GHA Companies (GHA) requires access to 1300 Baristo Road for the purposes of entering and traversing through the northwest portion of the property to access GHA's property adjacent to Baristo's north property line. GHA will construct a compact gravel road approximately 20 feet by 200 feet for access to the property as a controlled construction entry and exit for their proposed housing project. A Right of Entry Agreement has been prepared and includes a hold harmless agreement, insurance requirements and indemnification applicable to the project's scope of work. The temporary right of entry agreement shall commence on the Effective Date of the Agreement and is valid for 28 months.

Staff is requesting approval of a Right of Entry Agreement with the GHA Companies at 1300 Baristo Road and authorization for the Assistant Superintendent, Business Services, to execute the agreement.
